# Tunis Stock Exchange New trading hours

On proposal from Tunis Stock Exchange Board of Directors, the Financial Market Council approved the new trading hours, as detailed below, with effect from September 2<sup>nd</sup>, 2020.

### Winter trading hours (in local time):

- Start of Call phase at 8:30 am instead of 9:00 am (currently).
- Start of First uncrossing at 9:00 am instead of 10:00 am (currently).
- Start of second uncrossing at 11:00 am instead of 11:30 am (currently).

Thus, the trading session duration will be extended by 30 minutes. It will rise to 5 hours and 40 minutes, with one-hour extension in continuous phase.

#### Summer and Ramadan trading hours (in local time):

- For continuous trading groups, the first uncrossing will occur at 9:00 am instead of 9:30 am (currently)
- For fixing trading groups, the first uncrossing will occur at 9:00 am instead of 10:00 am (currently).
